
Communication and Chain of Command channeling concerns to Lisa Weigel, Joe Jefferson AD will help assist everyone.

Asked to send out information for games and changes earlier to get out to community and families.


Travel expense for families that travel 140 miles per day to get kids to our school. CDE transportation – isolation pay for families. Please check on this option.
