Motion was made by Hickert, seconded by Axsom to approve the agenda as presented. Voting: Axsom yes, Hickert yes, King ab, Schrock yes.



Mill Levy discussion on how the State is requiring districts to go up one mill per year until the local mills are at 27, which would be full funding.




