Athletic Director's Report:

Spring sports wrapping up, state track very good year. 10 kids. Golf Lilly qualified for state in Loveland, which is her second year. Athletic banquet is May 22. Parent survey to all parents, elementary and JH/HS: 16 received 2/3 yes, 1/3 no. considerations travel and expenses.

Board questioned: CHSAA deadline?

Coaches all on board, Missey has Jamie at Garretson's on hold for uniforms, has guaranteed they will be in on time. Some from Woodlin can't play – out of district. Arickaree needs kids next year to play. Junior High doesn't have enough to play. Next year 2025-2026: 6 girls in high school to play sports, 23 games are a lot on kids. The 10th grade and below are on board to do a coop. Juniors and Seniors have more of an issue. Missey works well with Deb Atwater. Practice from others? Communicate more expectations. Football camp half of the boys are from Woodlin, very dedicated from some of them. In a few years it will be lopsided. A 50/50 will equal out in all the years of the coop.

decide about a new well. Lydia to write letter to test water, find new operator – possibly one who services Woodlin. Floor is safe per John, system needs to be fixed. HVAC glycol leak, hose connections failed. To replace it will be over \$6,000.00 for hoses, labor extra.




